## VI. Review of POST hour requirements and capacity of academies

- A. Director Bourgerie explained that POST academies dedicate a minimum of two hours to this topic and in-service has no dedicated mandatory requirement for this topic. Colorado has one of the more rigorous overall in-service requirements nationally. The interpretation from Department of Law attorneys is that the number of hours should remain the same to minimize the administrative burden on POST and Academies. Additional training can be suggested, and it can be left at the discretion of academies.
  - 1. A question was asked about POST purview over in-service training. Director Bourgerie explained that while the total hour requirement is governed, individual training is not overseen by POST.
  - 2. There was continual discussion about the perception and opinion of various commissioners that the two-hour limit to academy training was not accurate or appropriate.
  - 3. Department of Law attorneys confirmed that the Commission does not have the authority to mandate additional training.

## VI. Commission duties regarding first responders (firefighters and EMS)

A. DOL attorneys explained that statute is permissive related to first responders, except for the responsibility of the commission to review existing curricula. The recommended curriculum can be posted on the POST website and/or provided directly to the governing agencies (DPS and CDPHE) and they can use it at their discretion.

## VII. Facilitated discussion

A. Commissioner Antista-Bianchi facilitated a discussion regarding a survey distributed to the commission and included: defining "disability", statutory mandated tasks, survey responses, requirements of training, and the motivation of individual commissioners to participate in the process.
