POST has considered adding a performance ranking system, and making this information available on the POST website. POST will then also use this information to determine which academies to audit. These statistics are currently available on the website, <a href="https://www.Colorado.gov/post">www.Colorado.gov/post</a>, click "Academy" and click "Colorado POST Academy Statistics"

Concerns about the shortage of officers was discussed. There were about 1200 POST academy graduates last year, 2 years ago 900, this year we're on track for over 1200. There are 3,000 with active certificates that are not currently employed.

An issue that arose was about the psychological exams administered for potential new hires, and what standards psychological examiners have. Marijuana has been a setback for passing the psych of late, because it violates federal law, but does that fit in today's world? There currently is not a standardized psychological exam, standards are set by the agencies. The applicants are required to take a psych exam administered by a state of Colorado licensed psychologist/psychiatrist, but there is no pass/fail definition.

#### 7. Academy Curriculum Proposal

Dir Erik Bourgerie

Proposal to adequately prepare peace officers for the street while they're in the academy, by focusing on scenario/reality based training. What would Colorado POST building blocks/ scenarios be?

- 1. Police/Law Enforcement History (Honor, Integrity)
- 2. Scenarios, increasing in complexity over time.

A Job-Task Analysis (JTA) has been proposed. The cost is predicted to be \$250k for the JTA and a 3-4 year buildout for the curriculum. POST has about \$1.5 million in a fund, but POST doesn't have spending authority, unless the board approves to take this first step. We anticipate that the money would be available July 2020, and the JTA would be done by 2021. The benefit would be that instead of an a-la-carte academy, it would make each academy teach the same curriculum, housed by POST. POST would incorporate SME members, law enforcement professionals and the community.

**Certification Stratification** 

Dir Erik Bourgerie

Advocacy for stratified Peace Officer (PO) certifications, in anticipation of POs gaining more training and to provide/set goals for individuals. Would also give them a chance to thrive within their agencies. These certifications could be tracked through a software program by POST staff. In order to make sure this isn't resource based, where larger agencies can pay for their PO's to gain training, POST can leverage the grants program to give rural agencies resources.

• Age Requirement 24-31-305(1)(a), C.R.S.

Straw Poll: Yes to 21 – Majority Support

- Additional Misdemeanors for Denial/Revocation of Certification 24-31-305(1.5)(a), C.R.S.
  - 1. Previously approved by Board
  - 2. Addition of 18-9-202, C.R.S., Cruelty to Animals

Need to clarify intentional and reckless animal cruelty.

Propose to add false imprisonment and prohibited use of a firearm.

Unanimous in favor.

Scholarship Grant Fund for Academy Attendance 24-31-310(3), C.R.S.

Recruits are prohibited from grant funding.

Proposition would modify the statute to say that POST may establish a scholarship fund to small rural agencies to send recruits to an academy, in return the smaller rural agencies would have more staff.

• Reciprocity – Provisional Certification 24-31-308, C.R.S.

1 year within previous 3 to gain POST Cert in CO for out of state recruits. POST has discretion to compare training to previous state.

Local Sheriff is required to have 1 PO to serve as a SRO.

Modification – K-12 public.

Only if you have a school in your primary jurisdiction you should have a SRO, if it does not impose undue hardship.

• Peace Officers Must Be Residents – Exception 29-5-101, C.R.S.

Modification – No residency whatsoever

11. Tactical Emergency Medical Services (TEMS)

TEMS have previously served a "deputy status", and are being sent to Reserve academies. The issue is that insurance companies won't cover TEMS if they are not law enforcement employees.

Review the agencies for ways to improve and educate. Firearms committee has proposed a way to receive a report on cases of lethal force. Provisions/Protective order on cases that are going to court/ becoming a lawsuit. Propose a law that POST can guarantee that information will not be released.

Across border agencies to have an agreement to combine and create a SWAT team.
