8. Training Grants

a. Subcommittee Openings

AG Phil Weiser

Two current grant subcommittee members' terms are coming to a close. There is a need to fill these vacancies by April 28th. Board Members should email Director Bourgerie of any desire to join the subcommittee.

The next Grants Subcommittee meetings is on April 28th, 2020.

b. Term Limits AG Phil Weiser

There are no current subcommittee term limits. The maximum number of POST Board Member terms is two. Both terms are 3 years in length.

# c. Supporting Rural Collaboration

AG Phil Weiser Chief Funston

There are regional agreements between Palisade PD, Fruita PD, Grand Junction PD, and Mesa County SO to spread resources with officers becoming sick, and low supplies. These agencies have extended the lines of communication with other agencies and sectors (first responders).

Silverthorne has done comprehensive community exercises for over a decade from wildfire, flood, and emergency hospital surges. Officers have been deputized by the Summit County Sheriff as a mutual aid agreement in preparedness for civil unrest. The emergency operations center is functioning and receiving calls daily.

Steamboat Springs PD is sharing office space with Routt County Sheriff's Office.

Proposal to have the Grant Subcommittee provide guidance on how agencies can gain a "leg up", if they're collaborating with other agencies.

#### d. Preliminary Budget Ideas

## I. PoliceOne Academy

In the past, POST has set aside \$450k of the budget for Police One, with 265 agencies onboarded, and over 8,000 active users. This year, POST proposes setting aside \$200k for PoliceOne, and having agencies request in-service grant funding, instead of paying for the whole state, as some agencies are utilizing less than 10% of the program. POST would like to make funding more efficient and apply the savings to other programs.

# II. Public Safety Leadership Program

The last two years, \$140k was set aside to offer scholarships. POST has been paying for 30 spots but haven't been getting that enrollment.

This year, POST would like to set aside only \$74k out of the budget, for rural and small agency scholarships only.

#### III. Backfill Continuation

Rural agencies are under utilizing the program. \$40k is a little robust for this program to not be used. POST will continue to advertise and gain interest from rural agencies to use the program over the next year.

## IV. Capital Improvements

AG proposing a requirement of demonstrated collaboration before awarding, and use this as an incentive to support regional collaboration.

# V. Community Outreach

POST is requesting \$15,000 for community outreach/ public education.

POST is mandated to provide community outreach Funding has not been allocated in the past.
